this vacancy will be filled by appointment by the Board with 60 days from this date in accordance with the following procedure:

- 1. Interested persons are invited to send a letter to the Board with a statement of interest and related experience by February 1, 2016 to the following address: 403 W. 5th Street, Florence, CO 81226.
- 2. The Board will interview prospective candidates on February 8, 2016 at a public meeting.
- 3. No person is eligible to hold public office unless that person fully meets the qualifications for office. To be eligible for appointment, a candidate must be a registered elector of the school district for at least twelve consecutive months prior to the date of appointment. The candidate must also be a resident of the director district in which the vacancy exists. Any person who has been convicted of a sexual offense against a child is ineligible for the office of school director. Each candidate for appointment to the vacancy shall establish their eligibility to hold office by submitted a sworn affidavit attesting to their qualification for the office by February 1, 2016, to the address above.
- 4. The appointee will serve until the next regular school biennial election in November 2017 at which time an election will be held for a successor to fill the remainder of the unexpired term.
